

Qualified Entrant and Entry

- A qualified entrant (“Entrant”) is 19 years of age or older and has earned a ballot (“entry”) by complying with the **“Contest Details for Tables Golden Bonus”** and **“How to Earn Entries into the Draws for Tables Golden Bonus”** sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of Great Canadian Entertainment and its subsidiaries and affiliates (collectively, “CASINO CHILLIWACK”), and the British Columbia Lottery Corporation (“BCLC”), as well as family and household members of same who reside at the same address.
 - Voluntary self-excluded, CASINO CHILLIWACK site barred and BCLC provincial barred persons, and residents of Québec.

Contest Details for Tables Golden Bonus

- The Contest Period runs from **Monday, March 30, 2026 until August 31st**.

How to Earn Entries into the draws for Tables Golden Bonus

There are **two (2) ways** to enter the **draws**: Earning Entry through Table Game Play, or with a “Self-Addressed-Stamped Envelope” alternative.

1. Earning Entry through Table Game Play

- Entrant(s) can earn one (1) entry by the following requirements: \$25 buy-in or more on table games and after wagering at least \$25 on any Table Game at Elements Casino Chilliwack during the promotional period of Sundays, Mondays and Thursdays.
- Entrant(s) can earn a maximum of three (3) entries per week during the promotional period. One (1) ballot per day only on promotional days.
- Available only to all carded players (Encore Rewards member) who play at Elements Casino Chilliwack.

2. “Self-Addressed Stamped Envelope” Entry (“SASE Entry”)

- No purchase necessary. entries arrive on time; as set out below, CASINO CHILLIWACK is not responsible for any lost, misdirected, or incomplete entries.

- Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

Draw Procedure for the Tables Golden Bonus

Two (2) registered CASINO CHILLIWACK gaming employees will conduct draws:

- There will be one (1) winner every Monday at 7PM that will receive \$300 in free play.
- One (1) entrant will be drawn at 7PM on Mondays.
- If there is no confirmed winner, there will be a total of five (5) redraw. After five (5) redraws the prize will carry forward to the following Monday.
 - For example, if there is no confirmed winner the \$300 in free play would carry over to the following Monday and the total prize would become \$600 in free play.
- Once the player meets the criteria, security will perform security checks on the Entrant for eligibility verification.
- The player must present their Encore Rewards card at the time of the draw. If the player is not a current member of the Encore Rewards program, there will be a redraw.
- The Winner will fill out the Prize Redemption Form and receive their \$300 in free play loaded onto their Encore Rewards card.
- The prize is non-transferable and there are no substitutions.

Prize Claiming Conditions for Tables Golden Bonus
